FEES and CHARGES

Effective: **July 10, 2016**

“Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedule.”

DEFINITIONS

1. “Regular hours” means 7:00 a.m. to 4:30 p.m., Monday through Friday. All hourly fees will be assessed in quarter-hour increments, per individual necessary to perform the service. The regular hourly rate will be charged at \$20.00 per hour.
2. “Overtime” means work performed during any hour other than the regular hours or holiday hours as defined. Overtime hourly rate will be charged at \$30.00 per hour.
3. “Travel time” means time spent in round trip travel from portal to portal. If an employee performs inspections at several locations on one trip, travel time may be prorated and the appropriate hourly rate will applied.
4. “Holidays” means:

New Year’s Day
Labor Day

Memorial Day
Thanksgiving Day

Fourth of July
Christmas Day

Holiday hourly rate will be charged at \$40.00 per hour.

5. “Standby time” means idle time spent at customer facility due to customer-caused delays. Standby time will be charged at the applicable hourly rate.
6. “On-Call Charges” is when an applicant requests personnel to be available outside regular business hours. Personnel are off-site waiting to report for duty. Elevator must establish a starting time for KGIS personnel to be available for work. Elevator personnel will contact KGIS personnel before the starting time to report on the loading status. If the elevator is not ready, an on-call charge of two hours per person will be assessed at the applicable hourly rate. No more than two on-call charges per person per day will be assessed.

The appropriate hourly rate will be applied for sampling services.



Mileage: The IRS standard mileage rate will be assessed for all services performed outside the service point city's limit. Any charge to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage will be prorated when possible.

Official commercial inspection service is provided upon agreement between Kansas Grain Inspection Service, Inc and the applicant. Fees charged are dependent upon modification to the service. Inquiries should be forwarded to the Kansas Grain Inspection Service, Inc. (KGIS), P.O. Box 750077, Topeka, Kansas 66675.

When no fee for service has been established, the hourly rate will apply.

Interest will be assessed on unpaid accounts which are in excess of 60 days. The rate of interest charged will be set by the KGIS trustees and will not exceed 18% A.P.R.

Per Diem Expenses: \$21 per day, per individual, plus actual lodging expense not to exceed \$90, when required to stay overnight away from main office location.
