Schedule of Fees and Charges

EFFECTIVE DATE: July 1, 2016. The Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will assess only those fees appearing on their current approved fee schedule.

REGULAR HOURS: 7:00 AM to 4:00 PM Monday through Friday except holidays.

REGULAR HOURLY RATE: \$22.50 per hour per person.

Rates are assessed in quarter hour increments. SCI reserves the right to determine the number of personnel to properly provide the service requested.

OVERTIME HOURS: One and one-half the regular rate for work performed on Saturday and other than regular hours.

SUNDAY and HOLIDAY HOURS: Two times the regular rate. Holidays are: New Year’s Day, Presidents Day, Memorial Day, 4th of July, Labor Day, Thanksgiving Day, Christmas Day, and after 11:00 AM on Christmas Eve and New Year’s Eve.

STANDBY RATES: Will be charged at the applicable hourly rate for delays not caused by the agency. A minimum call out charge of four (4) hours will be assessed at the applicable hourly rate outside of regular hours.

MILEAGE RATE: The IRS standard mileage rate will be assessed for all services performed basis service point’s city limits. Any change to the mileage rate is effective when the IRS changes their standard rate. Mileage may be prorated when more than one point is provided service per trip.

OFFICIAL INSPECTION SERVICES: Mileage and delivery charges are in addition to unit fees listed below. Standby and travel hours will be assessed at applicable hourly rates. Overnight lodging costs will be charged when incurred.

ONSITE LAB STAFFING: Applicable hourly rate for inspector(s) and or technician(s) plus travel time, mileage and unit fees.

EXTENDED LOAD TIME FEE: On-Site minimum of seven (7) railcars per hour average for the train. Amounts less than seven (7) railcars per hour will be billed at the current railcar rate. Maximum charge \$500.00 per train.



PERSONNEL SAFETY: It is the customer’s responsibility to make the grain or stowage area accessible. On barges and railcars SCI employees do not open or close doors or lids. On tops of railcars there must be a minimum of two people at all times. This can be two SCI employees or one SCI employee and one customer employee. This is to “render aid if needed” which could be to call for assistance.

AMA FEES

MILEAGE FEE- MILEAGE RATE: THE IRS STANDARD MILEAGE RATE WILL BE ASSESSED FOR ALL SERVICES PERFORMED BASIS PORTAL TO PORTAL. ANY CHANGE TO THE MILEAGE RATE IS EFFECTIVE WHEN THE IRS CHANGES THEIR STANDARD MILEAGE RATE. MILEAGE WILL BE PRORATED WHEN MORE THAN ONE ELEVATOR PER TRIP.

HOURLY RATES- HOURLY RATES WILL BE CHARGES IN QUARTER HOUR INCREMENTS. ALL OVERTIME, SUNDAY, AND HOLIDAY RATES WILL BE ASSESSED IN ADDITION TO UNIT FEES. OVERTIME WILL BE ASSESSED FOR ALL WORK PERFORMED OUTSIDE REGULAR HOURS. A MINIMUM CALL OUT CHARGE OF FOUR (4) HOURS AT APPLICABLE HOURLY RATE OUTSIDE REGULAR BUSINESS HOURS WILL BE ASSESSED. HOLIDAYS INCLUDE: NEW YEARS DAY, MEMORIAL DAY, JULY 4TH, LABOR DAY, THANKSGIVING, CHRISTMAS.
