) Complaint

There is reason to believe that the Respondents named herein have willfully violated the Packers and Stockyards Act, 1921, as amended and supplemented (7 U.S.C. § 181 et seq.; hereinafter “Act”) and the regulations promulgated thereunder by the Secretary of Agriculture (9 C.F.R. § 201.1 et seq.; hereinafter “Regulations”), and, therefore, this complaint is issued alleging the following:

I.

(a) Vermilion Ranch Company, d/b/a Billings Livestock Commission Company (hereinafter “Corporate Respondent”), is a corporation organized and existing under the laws of the State of Montana, whose mailing address is 2443 N. Frontage Road, Billings, Montana 59101.

(b) At all times material herein, Corporate Respondent was:

- (1) Engaged in the business of a market agency buying and selling livestock in commerce on a commission basis; and
- (2) Registered with the Secretary of Agriculture as a market agency to buy and sell livestock in commerce on a commission basis.

(c) Patrick Goggins (hereinafter “Individual Respondent”), is an individual whose mailing address is P.O. Box 30758, Billings, Montana 59107.

(d) At all times material herein, Individual Respondent was:

- (1) President of Corporate Respondent;
- (2) Fifty percent owner of Corporate Respondent; and
- (3) Responsible for the direction, management, and control of Corporate Respondent.

II.

Corporate Respondent, under the direction, management, and control of the Individual Respondent, was placed on notice, by certified mail received on or about July 13, 2006,¹ that they were operating with a Custodial Account for Shippers’ Proceeds (hereinafter “custodial account”) shortage. Respondents were informed that the shortage was due, in part, to the market’s failure to reimburse the custodial account in a timely manner for owner and employee purchases and, also, to the market’s failure to reimburse the custodial account for proceeds receivable that were not collected by the close of the seventh day after sale. The letter directed Respondents to section 201.42(c) of the Regulations (9 C.F.R. § 201.42(c)) and informed them that failure to timely reimburse the custodial account was an unfair trade practice in violation of

sections 307(a) and 312(a) of the Act (7 U.S.C. §§ 208(a), 213(a)). The letter also placed Respondents on notice that they were allowing the auctioneer to buy cattle out of consignment while working in the capacity of auctioneer in violation of section 201.56(c) of the Regulations (9 C.F.R. § 201.56(c)). Finally, the letter informed Respondents that failure to correct the violations could result in penalties up to \$11,000.00 for each violation.

III.

Corporate Respondent, under the direction, management and control of Individual Respondent, during the period of November 13, 2006, through January 24, 2007, failed to maintain and use properly its custodial account, thereby endangering the faithful and prompt accounting of shippers' proceeds and the payment due the owners or consignors of livestock in that:

(a) As of November 13, 2006, Corporate Respondent had outstanding checks drawn on its custodial account in the amount of \$1,565,700.79 and had to offset such checks, a balance in the custodial account of \$798,478.38 and proceeds receivable of \$701,434.30 resulting in a deficiency of \$65,788.11.

(b) As of January 24, 2007, Corporate Respondent had outstanding checks drawn on its custodial account in the amount of \$493,711.56 and had to offset such checks, a balance in the custodial account of \$296,064.85 and proceeds receivable of \$131,584.62 resulting in a deficiency of \$66,062.09.

(c) The shortages in Corporate Respondent's custodial account were due, in part, to Corporate Respondent's failure to deposit in its custodial account, within the time prescribed by section 201.42 of the Regulations (9 C.F.R. § 201.42), an amount equal to the proceeds receivable from the sale of consigned livestock.

IV.

(a) Corporate Respondent, under the direction, management, and control of Individual Respondent, on or about the dates and in the transactions set forth below, failed to maintain properly its custodial account in violation of section 210.42 of the Regulations (9 C.F.R. § 201.42) by failing to timely reimburse its custodial account for its own livestock purchases by the close of the next business day following the sale of the livestock.

(c) Corporate Respondent, under the direction, management, and control of Individual Respondent, on or about the dates and in the transactions set forth below, failed to maintain properly its custodial account in violation of section 201.42 of the Regulations (9 C.F.R. § 201.42) by failing to timely reimburse its custodial account for livestock purchases made by buyers who had not paid by the close of the seventh business day following the sale of the livestock.

V.

(a) Corporate Respondent, under the direction, management, and control of Individual Respondent, on or about the dates and in the transactions set forth in Appendix A and incorporated herein by reference, permitted its auctioneer, Ty Thompson, to directly purchase

livestock out of consignment for his own account in violation of section 201.56(c) of the Regulations (9 C.F.R. § 201.56(c)).

(b) Corporate Respondent, under the direction, management, and control of Individual Respondent, on or about the dates and in the transactions set forth in Appendix B and incorporated herein by reference, permitted its auctioneer, Ty Thompson, to indirectly purchase livestock out of consignment for his own account in violation of section 201.56(c) of the Regulations (9 C.F.R. § 201.56(c)). Dan Selle, d/b/a Selle Livestock, purchased livestock on a commission basis for Ty Thompson.

VII.

By reason of the facts alleged in paragraph I, Individual Respondent is the alter ego of Corporate Respondent.

By reason of the facts alleged in paragraphs III and IV, Respondents willfully violated sections 307 and 312(a) of the Act (7 U.S.C. §§ 208, 213(a)), and section 201.42 of the Regulations (9 C.F.R. § 201.42).

By reason of the facts alleged in paragraph V, Respondents willfully violated section 312(a) of the Act (7 U.S.C. § 213(a)), and section 201.56 of the Regulations (9 C.F.R. § 201.56).

WHEREFORE, it is hereby ordered that this complaint shall be served upon Respondents for the purpose of determining whether Respondents have willfully violated the Act and the Regulations. Respondents shall have twenty (20) days after receipt of this complaint in which to file an answer with the Hearing Clerk, Room 1031-South Building, United States Department of Agriculture, 1400 Independence Avenue, S.W., Washington, D.C. 20250-9200, in accordance with the Rules of Practice Governing Formal Adjudicatory Proceedings Instituted by the Secretary Under Various Statutes (7 C.F.R. § 1.130 et seq.; hereinafter “Rules of Practice”).


Allegations not answered shall be deemed admitted for the purpose of this proceeding. Failure to file an answer will constitute an admission of all the material allegations of this complaint.

The Packers and Stockyards Program, Grain Inspection, Packers and Stockyards Administration (GIPSA), requests:



2. That such order or orders be issued, including an order requiring Respondents to cease and desist from the violations of the Act and the Regulations found to exist, suspending Respondents as registrants under the Act, and assessing such civil penalties against Respondents as are authorized by the Act and warranted under the circumstances.
